

"QUICK QUACK UTAH TECH" SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of Utah who live within 75 miles of the Utah Tech University located at 225 South University Ave. St. George, UT who are 18 years of age or older at the time of entry. You need not be present to win. Employees (and their immediate families or those living in the same household) of Quick Quack Car Wash Holdings, LLC (“Quick Quack” or “Sponsor”); and its affiliates, subsidiaries, divisions, parent and related companies are not eligible to enter or win.

2. **HOW TO ENTER:** Sweepstakes begins at 12:01 a.m. PST on September 1, 2023 and ends at 11:59 p.m. PST on June 15, 2024. You may enter this Sweepstakes via either the on-line or mail-in entry methods described below. Regardless of entry method you may enter only once per person per day. All entries must be received by 11:59 p.m. PST of the last day of the Sweepstakes, i.e. June 15, 2024, whether submitted on-line or mailed-in. Proof of depositing entry in mail is not considered proof of delivery or receipt. No photocopied or mechanically reproduced entries will be accepted.
